Respected Sir,
We all from Noida Entrepreneurs Association convey our greeting. Jai hind Jain Bharat.

We would like to applaud and express our deep gratitude for very efficiently and effectively handling COVID 19 Pandemic. We are quite sure this would not be able to do much loss in form of lost Human life in India due to proactive timely steps taken by you and the State Government headed by very able determined leader respected Shri Yogi Ji.

While expressing our solidarity and commitment of 10200 Industrial Units of Noida, Greater Noida and Yamuna Expressway closing all our industries with paid leave to our thousands of staff and lacs of labour force. There is no Industrial activity for almost a month but we stand by your directives to pay wages to all our lacs of employees. However in addition to the salary and wages, we are having load of Electricity, water , interest on term loan, working capital, lease rent, rentals and other dues to be paid.


We would seek your kind attention to the challenges and hurdles we are going to face in coming months after eradication of COVID-19, which we are sure is not far off , requesting you to help us by –

1. While thanking the Hon'ble FM for extending the dates of returns of GST, Income Tax we request for extension of due dates of Registrar of Companies and all other statutory organizations to be filed in the Month of March 7 April to 30th June 2020.
2. Delay payment of all dues towards GST, Income Tax etc whatever is due in March 2020 to 30th June 2020.
3. All loan EMIs due for March 2020 may kindly be extended till 30th June 2020 with instalment facility and waiving off interest for this period.

4. SBI's leadership of enhancing the working capital limits by 10% is highly appreciated but this is not enough. Kindly direct all banks and other financial institutions to stand by the industries in this difficult time by extending the limits and other loans by 20% for the next fiscal year so that we may come out of the gloom.
5. We shall request our Dynamic Chief Minister Shri Yogi Ji to defer payments of all instalment of Industrial land, lease rents, water and Electricity dues for next three months with instalment facilities extending up to 30th September so that the industry may not face liquidity crunch.

We seek your worthy favoured attention in the matter at the earliest and oblige.
