
1. Withdraw the minimum charges of Electricity bills as our units are closed and we would not be using electricity for almost a month as gearing up for restarting of industrial units after 23 days shall take another 10 days.
2. Payment of all state dues towards GST, ESI and PF etc whatever is due in March 2020 to 30th June 2020.

3. All bank and other loan EMIs due for March 2020 may kindly be extended till 30th June 2020 with instalment facility and waiving off interest for this period.
4. Local bodies and industrial authorities as Noida, GNIDA, YEIDA etc may be instructed to waive off lease rent, water charges and all other charges for the month and delay all instalments due in March and April till 30th September 2020.

We seek your worthy favoured attention in the matter at the earliest and oblige.
